Wrightstown Sports Complex Plan Approval Resolution #2018-09. Solicitor MacNair reviewed Resolution #2018-09 approving a proposed athletic facility on premises located at 2236 Second Street Pike. There was discussion on external lighting and the required financial escrow for tree replacement as

per the Stormwater Maintenance Agreement. On a motion by Treasurer Lloyd, seconded by Vice Chair Magne, the Board voted unanimously to approve the Resolution.

- **C.** Lingohocken Fire Company Report. Chair Pogonowski reviewed the January 2018 report. There were 18 calls for service, 94 man-hours for responses, 104 man-hours for training and 24 man-hours for work details, for a total of 222 man-hours of service to the community.

- **E. Historical Commission Minutes.** The Board accepted the Historical Commission meeting minutes of January 11.
