Minutes

Call to Order: Chair Betty Davis called the meeting to order at 1:10 p.m.

Present: Chair Betty Davis, Mary Lee Johnson, and Karl Niederer. Absent Jane DelBianco and Beverly Wilson. Guests: Jane Magne, Township Supervisor; and Lisa Loeffler Fee, volunteer (presentation following adjournment at 2:50 p.m.).

Agenda: Additions and Changes - None.

Approval of Minutes: 2 October 2025 meeting. APPROVED with one correction to Old Business, item #4, Placing Prints in Township Building. It should read "Mary Lee will adjust location of one print in the Administrative office."

Treasurer's Report: No report presented.

Old Business:

- 1. **Quaker History Exhibit** Karl reported he will work with David Dutko to create the expanded virtual display of items from the *Quakers in Wrightstown* exhibition in the Township's web site.
- 2. Octagonal School—
 - Open Houses -
 - Osunday, 19 October Betty announced 51 visitors attended the season's final Open House and its featured *Tunes of the Times* musical program. Cash donations of \$41 were received. Letters of thanks to musicians Marti and Bob Stevens, and Nancy and Forest Deal, and \$100 honorariums to both couples will be sent this week in gratitude for their participation (ATTACHMENT A).
 - Sunday, 21 September A letter of thanks to County Recorder of Deeds Dan McPhillips has been prepared, to be sent enclosing a check for over \$300 in cash donations received from visitors attending the featured program *In Word and Deed* at the Open House (ATTACHMENT B).
 - Franklinia tree No report on the tree's status.
 - Parking solution Jane Magne reported that Twining Construction is committed to
 install a permeable parking area in the field accessed via Swamp Road adjacent to the
 Octagonal School per designs and plans from Township Engineer, Cindy Van Hise.
 Jane will loop the Commission in with Cindy to review the plans and location of the
 parking area before Twining proceeds with the project.
 - **Fall cleanout** Betty, Mary Lee, and Karl agreed to clean out the Octagonal School contents on Wednesday, 12 November, at 1:00 p.m.
 - Security alarm system control device upgrade Mary Lee will look into replacement or alternative devices for controlling the school alarm system, since the current ones are unreliable.
 - Special programs for 2026 The Commission members agreed to try offering a featured or special program at each of the six (6) scheduled Open Houses next year, since such programs seem to attract media interest and greater public attendance.

Ideas for featured programs included:

- o Tunes of the Times, an encore musical performance
- In Word and Deed, an encore display of Bucks County deeds by the County Recorder's Office
- o **Penmanship and calligraphy of the 19th century**, with Robert Hurford
- Octagonal School adult art show, featuring professional-quality artwork of artists such as Joanna Krasnansky and others
- Octagonal School student art show, encouraging interested students from Wrightstown Elementary School to produce individual artworks of the Octagonal School for display at the May 2026 Open House. It will require engaging the art teachers at the school as early in 2026 as possible so students have time to prepare their artwork before May.
- 3. Commission Report to Township Supervisors Karl reported to the Supervisors on 20 October, highlighting record attendance at the Octagonal School Open Houses in August, September, and October, improved Open House parking, and the successful launch of the Wrightstown Historical Information Scanning Project (WHISP) in August.
- 4. **Placing Prints in Township Building** Mary Lee will adjust the location of a print in the Administrative office immediately after the meeting.
- 5. **Mega Way Development History** Jane Magne plans to resume work on this project during the winter in 2026.
- 6. Wrightstown Historical Information Scanning Project Karl reported that Jeffrey Marshall has agreed to volunteer as an advisor to the project to guide efforts to make its products as useful to researchers as possible. The Commission members agreed to join WHISP volunteer Lisa Loeffler Fee at her workstation across the hall following the meeting so she can demonstrate her progress and challenges to date.

New Business:

- 1. **2026 Commission Meeting Dates:** The Commission agreed to hold its regular meetings next year on the first Thursdays of each month at 1:00 p.m., except for the January meeting: on the 8th instead of the 1st. Karl will provide the list to Ms. Sadovy for publication as soon as possible (see ATTACHMENT C).
- 2. **Commission Report to Township Supervisors**: Karl will present a report of activities at the Supervisors meeting on 17 November.
- 3. **Special Program or Event to Commemorate the Nation's 250th:** The Commission will discuss whether to plan a special observance of the 250th during 2026, possibly one of the featured events at an Octagonal School Open House.
